NEW BUSINESS:

A. Residential/Commercial Developments Update

R. Shrack shared updates. For Prairie Lakes/TIF District area, Ironhorse Development is about halfway through the dirt work project to raise the area out of the floodplain. Infrastructure prep work is beginning for Cedar Ridge. The lowest qualified bidder was approved to do the infrastructure work for Arbor Valley. City Council has approved the final plat for Sunflower Valley. The city is still working with developers on platting the recently annexed portion of land south of the high school. Board Member Hoffman inquired about the status of the duplexes on Ford St. Shrack informed the board that they have moved into interior work and this project is being done is phases.

B. Ford Street Construction Update

B. Clark gave an update on the upcoming road closures for Ford Street and Seneca Street beginning on Monday, September 12th. A copy of the traffic plan map can be found on the city website. This will be in effect for several months. Board Member Colbert inquired about the leveling of parts of Ford St. B. Clark responded that there will be a little bit of flattening but there will still be hills. Along with curbing and concrete flumes at the bottom to help move water.

C. Location of Future Meetings

Discussion was had about the board meeting in person or to continue with virtual meetings. It was decided that the board will meet in person the last month of each quarter with the first in-person meeting to be held on December 7th, 2022, the location is still to be determined.
