APPROVAL OF DRAFT MINUTES

Motion was made by Board Member Jackson and seconded by Board Member Colbert to approve the meeting minutes for September 7, 2022. Motion was unanimous.

NEW BUSINESS:

A. Residential/Commercial Developments Update

R. Shrack shared updates. Infrastructure work has begun in Cedar Ridge and Arbor Valley. Dirt is being moved in the TIF district to remove that area from the floodplain. Bids will open on October 25th for infrastructure work in Sunflower Valley. B. Clark updated that Officer Leeker is in the process of getting licensed and certified as a drone operator. He will be collecting images and video of the construction projects and progress

B. Main Street Valley Center Progress Report

R. Shrack shared that board members from Main Street Valley Center were able to host the Kansas Main Street Team and a representative from Main Street America for a baseline assessment visit. A report will be generated as well as some action items and steps that can be worked on as a board. R. Shrack also gave information on how anyone interested could become involved with Main Street Valley Center.

C. Ford Street Construction Update

B. Clark shared the updates. The south lane on Ford St. is ripped up to just passed Brookfield Apartments. The current plan is to have the curb poured early next week and the concrete laid on the south lane potentially the same week. Once this is complete, they will start on the north side of the road. When the curb machine is done in this area it will move and begin working on curbing just east of Seneca St. We currently have three different construction crews working in different areas along Ford St.

D. General Discussion

R. Shrack reminded that our first in person meeting will be held at Builders First Source on December 7th, 2022, at 12:30 P.M. The following in person meetings will be March 1st, June 7th, September 6th, and December 6th of 2023. The hosts' and locations are TBD.
