## **Temporary Closing of Spaces Inside of City Facilities**

In an abundance of public caution, the City of Valley Center is taking several proactive steps to combat and limit the spread of the coronavirus pandemic locally. The City of Valley Center will be temporarily closing Public Spaces inside of all City Facilities, **effective Friday, November 13<sup>th</sup> beginning at 7:00am until further notice.**

The following locations will be affected:

- **City Hall Lobby** – Payments & Paperwork will be accepted electronically, over the phone, or via the drive-thru window during normal business hours.

- **Public Works/Parks/Community Development Lobby** – Permits, Payments, & all Paperwork will be accepted electronically, over the phone, or via the drive-thru window at City Hall during normal business hours.

- **Public Safety Lobby** – Payments & Paperwork will be accepted electronically, over the phone, or via the drive-thru window at City Hall during normal business hours. **There will not be Finger Prints processed during this time.**

- **Library/Community/Senior Center Lobby** – Public Library will provide materials by drive-up in front of the building only if you call in advanced to make a request or via email to [valleycenterlibrary@yahoo.com](mailto:valleycenterlibrary@yahoo.com). Senior meals will still be provided on Tuesdays & Thursdays via drive-up on the eastside of the Community Building.
